The Government of Kenya, through the Ministry of Health (MOH) with support from the World Bank, is implementing the COVID-19 Health Emergency Response Project (C-HERP). The Project aims to support the Government of Kenya's efforts to prevent, detect and respond to the threat posed by COVID-19 and strengthen national systems for public health preparedness and intends to apply part of the support for this Consultancy Service.

The project intends to engage a consultant to undertake consultancy services for design and construction supervision of Kenyatta National Hospital Infectious Diseases Unit.

The assignment will be carried out in two phases; Phase I is expected to take 6 months and 18 months for Phase II:

- Phase 1 will include feasibility site surveys, Environmental and Social Impact Assessment, preparation of designs, working drawings and contract documentation and provision of assistance to Ministry of Health in the preparation and evaluation of bids.
- Phase 2 will commence after the successful completion of Phase I and will include the supervision of the construction works to ensure that the works are carried out following the contract drawings and specifications, on time, within the contract amount and to the specified standards. This phase will also include providing detailed equipment identification and specifications for the Infectious Disease Unit and monitoring the works during the 6 months defects liability period and the Consultant will be required to sign off the buildings at the end of this period.

The Ministry of Health hereby invites eligible Applicants to Express their Interest in delivering the Services described above. This Request for Expressions of Interest is open to Consultant Firms or Consulting Firms in Joint Venture.

The Ministry of Health will shortlist submitted applicants, to whom the Request for Proposals to carry out the Services shall be sent. A Consultant will be selected as per the Quality and Cost Based Selection (QCBS) method set out in the Procurement Guidelines.
