The Ministry of Health now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. To be shortlisted,the Consultants must meet the following requirements:

- Core Business: Be registered/incorporated as a consulting firm with a core business in the field of communications, marketing or related field for a minimum period of five years.
- 2) Relevant Experience: The firm shall demonstrate a successful track record by having executed and completed a minimum of a minimum of three assignments of a similar nature and complexity in a comparable operating environment. Details of similar assignments must be provided, including the name and address od the client, scope of work, contract value and the duration of the assignment. The expression of interest should enumerate these similar past assignments.

3) Technical and Managerail Capability of the Firm: The firm should showcase the technical and managerial capacity to effectively undertake the assignment. This will be demonstrated through the submitted company profile(s) detailing the firm's capabilities, resources and relevant expertise. Do not provide the CV of staff.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" September 2023 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.neither a Consultant (including personnel and sub-consultants), nor an affiliate (that directly or indirectly controls, is controlled by, or is under common control with that Consultant), shall be hired for any assignment that, by its nature, creates a conflict of interest with another assignment of the Consultant;

In addition, please refer to the following specific information on conflict of interest related to this assignment: Consultants (including their experts and other personnel, and subconsultants), that have a close business or family relationship with a professional staff of the Borrower, or of the project implementing agency, or of a recipient of a part of the Bank's financing, or any other party representing or acting on behalf of the Borrower, that is directly or indirectly involved in any part of:

i. the preparation of the TOR for the assignment;

ii. the selection process for the contract; or

iii. the supervision of the contract;

may not be awarded a contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the Bank throughout the selection process and the execution of the contract as per paragraph 3.17(d) of the Procurement Regulations.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the **Consultant Qualification Selection** (**CQS**) method set out in the Procurement Regulations.
