The services included under this Project are the Design & Construction Phase and Supervision Consultancy Services for the Completion of Construction of the Research and Teaching Complex for the East Africa Centre of Excellence located at the Kenyatta National Hospital Grounds. The services cover the following areas: - Completion Design and Completion of Construction of Two (2No.) floors in terms of Finishes, Interior Fit Outs, Branding and Associated Mechanical & Electrical Services on the Existing East Africa Centre of Excellence Building.
